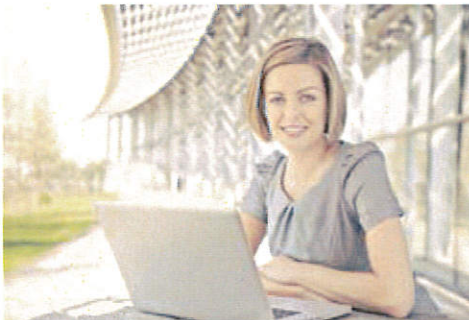

You do not need to maintain a minimum daily balance to obtain the bonus. Minimum opening deposit of \$50 required into new member checking account. Incentive cannot be used for opening deposit. \$5 shared savings account required. \$50 bonus is reported as interest and subject to a 1099-INT. Checking account or loan must stay open for a minimum of 60 days. A maximum limit of \$100 can be earned by any single new member. Some restrictions apply. Promotion may be discontinued at any time at the discretion of Four Points management. Federally insured by NCUA.
